*Confidential Arbitration* Jonathan recently won a confidential arbitration resulting in a savings to his errors and omissions carrier client of \$10 million.

*Fives St Corp. v. Allied World Surplus Lines Ins. Co.*, No. 5:22-cv-12683 (E.D. Mich.), *affirmed* No. 24-1921 (6th Cir. Jun. 10, 2025) The Sixth Circuit affirmed that the insured's prior knowledge of a dispute with an equipment purchaser precluded coverage for the underlying lawsuit.
